### Webinar Overview

Radiology services are pervasive across many areas of the hospital. Establishing the chargemaster to properly capture charges, codes and/or modifiers in the radiology area is of great importance for optimizing the revenue cycle. Many of the services provided through radiology are driven by order entry systems which then interface to the chargemaster. Interventional radiology, both surgical and cardiovascular, present special changes for charge capture and properly aligning the coding process through the chargemaster.

- review chargemaster techniques and associated coding and billing flow including differences between plain film radiology and interventional radiology
- understand the challenges presented with surgical interventional radiology

- review the proper use of Revenue Codes in connection with the CCRs (Cost-to-Charge Ratios) developed from the cost report
- examine how APCs are being changed in the interventional radiology areas
