#### **Medicaid RAC**

On April 11<sup>th</sup>, IHA meet with OMPP, Truven Health and HMS regarding an update on the Indiana Medicaid RAC activity. Current activity is related to Acute Care Hospitals and Long Term Care Nursing Facilities. The NF reviews are desk reviews of detailed financial history reporting. HMS continues to complete credit balance reviews for acute care hospitals. The schedule for credit balance reviews is annually for small to mid-size hospitals; bi-annually for large hospitals; and three times per year for larger groups.

The 2013 DRG validation audits did not seem to be very robust and they did not have any outcome information to share. However, they are going to begin data mining for potential automated findings where an improper payment can be identified clearly. OMPP would be notified of the area of concern before proceeding. Hospitals will be given the opportunity to refute the findings before any dollars would be recouped.

HMS and Truven continue to be open to having good communication with providers and encourage providers to contact them if they have any questions.

In addition, the Medicaid Managed Care Entities (MCE) have been encouraged to contract their individual recovery audit activity. It is our understanding that some of the MCEs have done so.

There has not been any new RAC information posted to the IndianaMedicaid.com website, however, they did say that they were working on an update.
