

# WAKE UP

WAKE UP promotes opioid and sedation management with the goal of reducing unnecessary sleepiness and sedation.

Reducing unnecessary sleepiness and sedation allows for early mobilization, reduction of delirium, decreased risk of respiratory compromise and shortened length of stay. Monitoring reversal agents and maintaining a continued emphasis on minimal sedation can help prevent several harm Events including ADE, FTR, delirium, falls, VAE, VTE and airway safety. Over-sedation is a common adverse drug event.
